- 15. That the cause of action for this complaint first arose on_____, and the same has since then been every day thereafter, and hence, this complaint filed today is well within limitation.
- 16. That the offence has been committed within the local limits of the jurisdiction of this Court, and hence, this Hon'ble Court has jurisdiction to try and decide this complaint.
