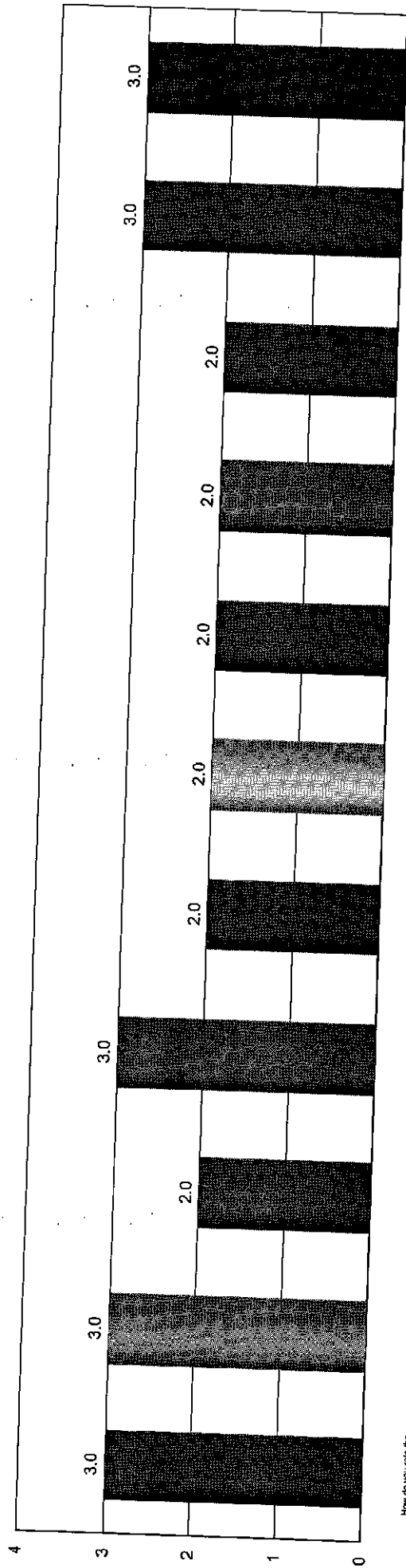
Action Taken Report of BA LLB, Session:2022-2023

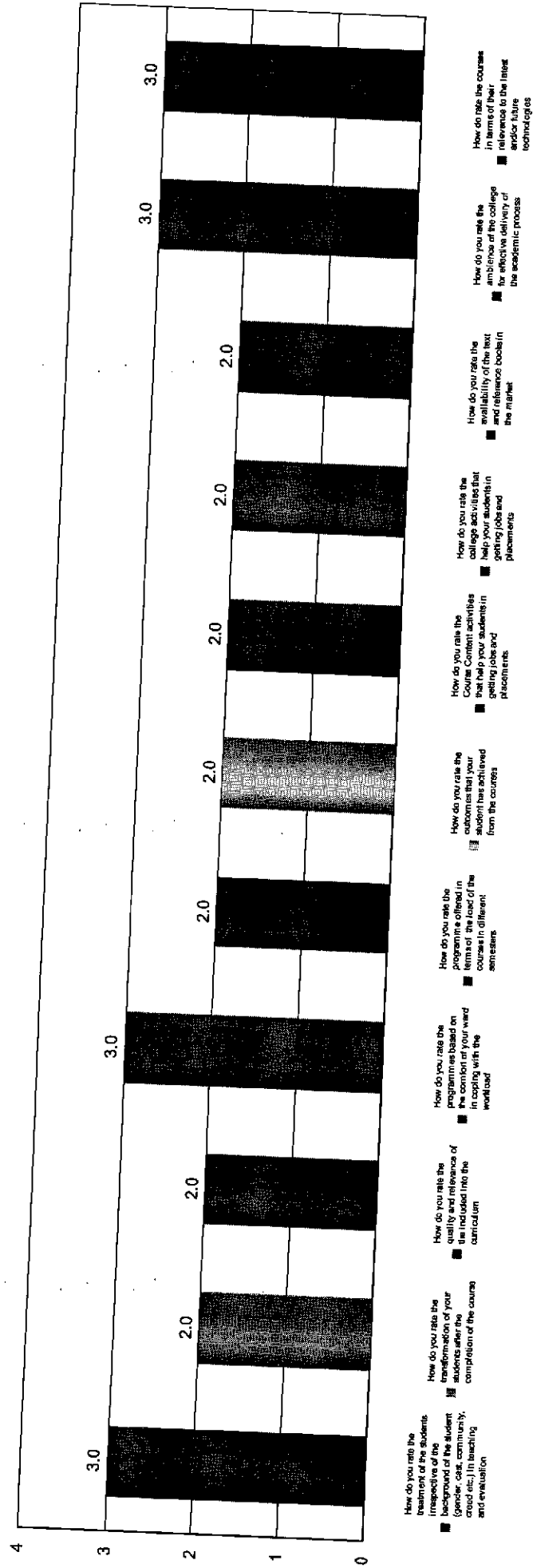

Action Taken Report of LLB, Session:2022-2023

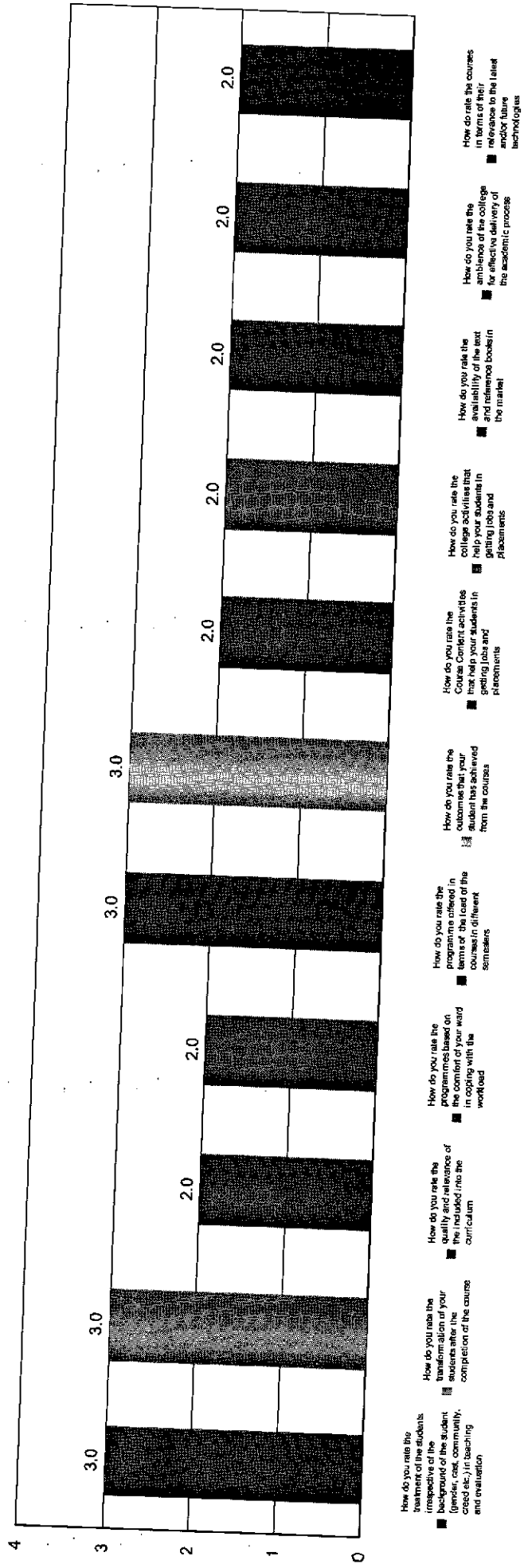
