Minutes of Meeting

The Chairperson welcomed the members and the following points were discussed in the meeting:

Agenda 01: Review of the activities during April-June, 2024

Dean-FASAI informed that in celebration of World Environment Day on 5th June 2024 on the theme of "Land Restoration, Stopping Desertification, and Building Drought Resilience." an event was organized in which the university community, including students, faculty members, and notable dignitaries, gathered to plant trees and saplings across the campus, reinforcing their commitment to environmental conservation.

Principal-FMS informed that on World Health Day 2024 a week-long series of events aimed at promoting global health awareness and advocacy were conducted from 2-10 April, 2024. 16 May, 2024 workshop on "Basic Life Support" was organized; Department of Community Medicine organized a series of events from May 17th to 20th May, 2024 to commemorate World Hypertension Day 2024. The theme for this year was "Measure Your Blood Pressure Accurately, Control It, Live Longer," that emphasizes the importance of precise blood pressure monitoring and management.

Dean-FJS informed that a MoU was signed between the Goa - Center of Excellence Intellectual Property (G-CEIP) in association with Goa College of Pharmacy (GCP) and the Faculty of Juridical Sciences on 30 May, 2024.

Principal-Faculty of Nursing informed that a successful CNE program focused on "Addiction Psychiatry" was organized on 4 May, 2024; celebrated International Nurses Week with a series of events highlighting the significant contributions of nurses to healthcare and the economy under the theme "Our Nurses- Our Future: The Economic Power of Care,"; 4th National Conference - 2024: "Transformative Nursing" was organized from 27-29 June 2024.

Dean FET apprised the members that on 26 April, 2024, "World Intellectual Property Day" was celebrated in collaboration with the Institution's Innovation Council.

Dean-FCM informed that on 23 April, 2024 conducted an extension and outreach activity in honour of World Earth Day. The initiative aimed to foster environmental consciousness and encourage sustainable practices among the younger generation. As part of this endeavour, faculty members and volunteers from FCM visited Prathamik Vidhyalaya in Kukradev Vikas Khand, Chaubepur, Kanpur Nagar, where they distributed plants to the students and imparted valuable knowledge about the importance of plantation and environmental conservation; on 5th May, 2024 sixty students from the Faculty of Commerce and Management proudly completed their 100 Hours Certification Program in Banking, Finance, and Insurance (CPBFI). This specialized program, offered in collaboration with Bajaj Finserv; organized a comprehensive expert session on "Preparing Detailed Project Reports for Agripreneurial Ventures." on May 6th and 7th, 2024

Principal- Faculty of Paramedical Sciences informed that Department of Optometry conducted a MOU activity with ZEISS Vision on 6th May 2024 aimed at enhancing students' understanding of innovation in vision care, focusing on measurement for dispensing.

Dean- Faculty of Pharmaceutical Sciences informed that International Conference on "Drug Delivery system on Nanomedicine, Phytomedicine with their clinical approaches" was organized on April 19th and 20th April, 2024.
