**MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is intended to promote cooperation and Socio-Educational activity between the Faculty of Juridical Sciences (FJS) Rama University, Kanpur (hereinafter referred to as "RU") and FOUNDATION FOR INNOVATION & RESEARCH IN SCIENCE & TECHNOLOGY, a company registered under Section 8 of the Companies Act, 2013 with its registered office at I.I.T Kanpur, Kalyanpur, Kanpur, Uttar Pradesh - 208016, India (hereinafter referred to as "FIRST") and represented by its Board of Directors and the authorized signatory shall be Director, Dr. AmithabhaBandyopadyay.

RU and FIRST are hereinafter referred to individually as the "Party" and collectively as the "Parties".

Whereas, Faculty of Juridical Sciences Rama University, Kanpur and FOUNDATION FOR INNOVATION & RESEARCH IN SCIENCE & TECHNOLOGY FIRS Thereby agree to enter into this MoU for the following purpose.

1. PURPOSE OF MoU

The purpose of this MoU is to develop social activity and educational cooperation in the areas of mutual interest and establish a collaborative program between RU and FIRST in accordance with terms and conditions set forth in this MoU.

2. AREAS OF COOPERATION

Cooperation shall be carried out through activities such as:

- (a) Conducting joint research and development project In Interest of society
- (b) Exchange of Skill
- (c) To promote the internship program
- (d) Participation in seminars or workshops on topics of mutual interest and to invite each other's faculty to participate therein.
- (e) Exchange of academic materials and other information

3. IMPLEMENTATION

- Any and all programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing through a separate agreement, including the necessary budget for the program of activity as the need may arise.
- The Parties will designate one representative each who will develop and coordinate specific programs or activities between them.

4. INTELLECTUAL PROPERTY

Both the Parties agree to respect each other's rights to background intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case by case basis through a separate agreement in writing.

5. DURATION AND RENEWAL OF THE MOU

This Memorandum of Understanding will become effective from ("Effective Date") for a period of one (1) year and is subject to revision of modification by mutual agreement in writing.

6. AMENDMENTS

- This Memorandum of Understanding may be amended by a written agreement signed by the representatives of both the Parties.
- In the event of any unforeseen incident during executing the collaborative activities under this MoU, both the Parties agree to negotiate a mutually acceptable solution.
- Should any disagreement arise out of the application, interpretation or implementation of this MoU, the Parties shall endeavor to exercise best efforts to negotiate their differences in a spirit of independence, mutual interest and shared responsibility.

7. TERMINATION OF MOU

This MoU may, at any time during its period of validity, be terminated by either Party upon prior notice to the other in writing not later than one month before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.

8. NO LIABILITY

Neither Party, nor any of their affiliates nor their or their affiliates respective directors, officers, employees, subcontractors or agents shall be liable to the other Party for any special, incidental, indirect or consequential damages (including, but not limited to, contract, negligence and tort liability) in connection with or arising out of this MoU.

9. PUBLICITY

Neither Party shall use the name of the other Party or its employees in any advertisement, press release or publicity with reference to this MoU without prior written approval of the other Party, except for necessary governmental disclosures.

10. ARBITRATION AND GOVERNING LAW

This MoU shall be constructed, governed, interpreted and applied in accordance with the laws of India and the courts of Kanpur shall have the exclusive jurisdiction.

The Parties shall attempt in good faith to resolve promptly any dispute arising out of or relating to this MoU by negotiation. If the matter cannot be resolved in the normal course of business, within ten (10) days after the dispute arises, any interested Party shall give the other Party written notice of any such dispute not resolved, after which the dispute shall be referred to Director, FIRST and Director, RU who will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

11. APPROVAL

In agreement with the above terms of participation, the authorized representatives of the Faculty of Juridical Sciences, Rama University, Kanpur and FOUNDATION FOR INNOVATION & RESEARCH IN SCIENCE & TECHNOLOGY Kanpur hereby affix signatures.
